Personal Data Protection Law No. 6698 (“**Law**”) grants personal data owners called data subjects the rights to make certain demands with regard to the processing of their personal data.

This Personal Data Protection Form is filled by data subjects to ensure applications they will file with Ege Yapı Anonim Şirketi (“**Company**”) acting as the data controller to be processed and applied in an efficient and detailed way under Section 11 of the Law.

2. Application methods

You can notify your demands about the processing of your personal data to the data controller Company by employing any of the methods described below:

- (i) Fill and sign this Personal Data Protection Form and deliver it by hand to Company's office located at Burhaniye Mah. Kısıklı K. Sultan Süleyman Sokak, Mabeyin Konakları No.4 D B1, Üsküdar, İstanbul; or
- (ii) Fill and sign this Personal Data Protection Form and send it to Company's e-mail address (info@egeyapi.com) from your e-mail account (KEP) registered with Company or from your electronic signature or mobile signature account or from the e-mail account you notified to Company and registered in Company's system.

Your demand will be met free of charge as soon as possible but within maximum thirty days depending on the nature of it; if meeting your demand incurs any cost, Company will ask you to pay that cost in accordance with the price tariff issued by the Personal Data Protection Board.
